Tuition fees are in Swiss Francs, VAT included.

Financial relations between parents and the school are regulated by the general conditions of Institut Florimont. In particular, it is to be noted that :

- Any request for enrolment or re-enrolment is subject to payment of enrolment or re-enrolment fees as well as a deposit for the school fees. Registration or re-entry fees are non-refundable, whether or not the student is admitted, and in case of non-acceptance, whatever the reason for the decision. The deposit is taken at the time of the first invoice in the first quarter.
- **Registration or re-entry as agreed and signed by the parent is a firm commitment. Therefore, in case of cancellation of the enrolment, the entire enrolment fees as well as part of the school fees are payable to the school, whatever the cancelling reason, under the following conditions :**
 - until March 31st : the tuition fees and the deposit are non-refundable ;
 - from April 1st to May 31st: the registration fee and the first half of the tuition fees for the first term are due ;
 - from June 1st: the registration fee and the whole of the tuition fees for the first term are due.
- School fees and half board pension are invoiced at the beginning of each quarter. They are payable immediately after the invoice is received.
- In the event of departure during the year, the school fees and, if applicable the half-board, for the current term are due in full.
- A reduction in fees is allowed based on the number of children at school. 25% off for the third child and 50% for the fourth child. **Children of former students benefit from a special reduction of 20% on school fees, the first year only.**
