A.3: LAWS AND GUIDELINES GOVERNING OBLIGATION TO REPORT SUSPECTED OR PROVEN CASES OF ABUSE AND MISTREATMENT

In accordance with Swiss federal law, a provision on child protection was introduced to the Civil Code and came into force on 1 January 2019. Article 314d states that educators and teachers have a duty to alert child protection agencies if there are clear signs that the physical, psychological or sexual integrity of a child is at risk.

Article 314d of the Swiss Civil Code

*The following persons, provided they are not subject to professional confidentiality under the Swiss Criminal Code, **are obliged to report to child protection agencies** if there are **clear indications that the physical, psychological or sexual integrity of a child is at risk** and that they cannot identify a solution within the remit of their professional activity: specialists from the fields of medicine, psychology, care services, childcare, **education, counselling, faith communities and sport** who have regular contact with children;*

persons who learn of such a case in their professional capacity.

*The duty to notify is fulfilled when a person notifies **their manager**.*

The cantons may make provision for further notification obligations.

Existing laws in the Canton of Geneva govern the duty to report suspected cases of child mistreatment.

Article 34 of the Law implementing the Swiss Civil Code and other federal civil laws, which came into force on 1 January 2013

*The following persons are bound by the obligation to alert the child protection service: **faith leaders and members of faith communities, health professionals, schoolteachers, instructors in religious, sports and recreational activities, local civil servants, police officers, social workers, educators, psychologists working in an educational setting, occupational therapists and speech and language therapists.***

*The duty to report a situation involving a minor is fulfilled when the person **notifies the child protection service**.*

In 2018 the Canton of Geneva adopted the Loi sur l'enfance et la jeunesse (Law on childhood and youth). At the request of private educational establishments, it was amended In November 2022 to include the possibility for private schools to request the intervention of the Département de l'instruction publique (public education, training and youth dept.) in complex mistreatment cases requiring urgent medical assessment.

Article 18 paragraph 3 of the Loi sur l'enfance et la jeunesse (Law on childhood and youth) of the Canton of Geneva (LEJ) (2018 amended in 2022).

As requested by private schools, authorising operation under the public education law of 17 September 2015, the department can intervene in complex mistreatment cases requiring urgent medical assessment.

In 2019, Geneva's public education, training and youth department adopted a directive on the role and responsibilities of private schools in detecting and reporting child protection cases. This directive was later amended to align with the new Article 18.3 of the Law on childhood and youth.

In the directive applicable to Institut Florimont, **every private school employee must report suspected or proven child protection cases to the Director who must address the case in consultation with the médecin répondant (school's doctor)**. As the person authorised to operate a private school, the Director is mandated to monitor these situations and if necessary escalate them to the Service de la protection des mineurs (SPMI) directly, or with the support of the Service de santé de l'enfance et de la jeunesse (SSEJ) if required.

Directive produced by Geneva's Département de l'instruction publique: "Enfants en danger et écoles privées", 2019 and 2023 (2023 version pending approval)

a) In view of the foregoing, **any private school employee** who receives information on situations indicating mistreatment must immediately notify the authorised person, the school Director, who will first address the situation in consultation with the médecin répondant (school's doctor).

b) In their role as person authorised to operate a private school, the **school Director** is mandated to monitor these situations and if necessary escalate them to the Service de la protection des mineurs (SPMI) directly, or with the support of the Service de santé de l'enfance et de la jeunesse (SSEJ) if required.
